#### **Memorial Resolution**

### **Donald Dean Myers**

Professor of Engineering Management & Systems Engineering (EMSE)

Donald Dean Myers was born in Oak Ridge, Missouri on October 15, 1939, to the late Paul Myers and Hester Frissell Myers. Don earned the B.S. in Mechanical Engineering here at the Missouri University of Science and Technology (then the Missouri School of Mines and Metallurgy) in 1961. After two years as a senior engineer with Westinghouse Electric in Baltimore, MD, he returned to Rolla to earn his M.S. in Mechanical Engineering. After working briefly at Emerson Electric, he joined Monsanto (both in St. Louis, MO) and served three years (1965-1968) as a senior engineer in design and project management while also earning a Master of Business Administration degree (1967) at St. Louis University. He moved to McDonnell Douglas Corporation (also in St. Louis) as a specialist in engineering contracts and corporate contracts (1968-1975) while he earned the Juris Doctor (Law) degree at St. Louis University (1973). Finally, he served McDonnell as Branch Manager, Corporate Diversification – Technology by Licensing from 1975 to 1979.

Don returned to Missouri S & T (by then known as UMR) as Assistant Professor of Engineering Management in August 1979, and was promoted to Associate Professor in 1984 and Professor in 1989. Our students benefited from Don's rich and varied education and corporate experience in courses such as Technical Entrepreneurship, Legal Environment (for engineers and engineering managers), Technological Innovation Management, and Case Studies in General Management. A colleague in the EMSE Department, Dr. Suzanna Long, praised Don as "a great ambassador for the department ... instrumental in shaping many careers." The campus Alumni Association gave him their Outstanding Student Advising Award in 2003, and the American Society for Engineering Management named as Best Dissertation in 2004 and 2005 research for which he was advisor. Don has served the EMSE department in many ways: on the Promotion and Tenure Committee since 1986, the Curriculum Committee since 1997, and on search committees for new faculty since 1997 and for a new Department Chair in 1999 and 2003.

Don served the Missouri S &T campus as a whole in multiple ways, too. He served as Director of Research Services and Negotiation Officer (1987-1993) and as Director of the Technology Search Committee (1983-1994). He has been a member (since 1985), committee chair, and president (2000-2001) of the Faculty Senate, and member (since 1998) and chair of two Academic Council committees. He was also a member (1998-2005) and chair (2002-2003) of the campus Promotion and Tenure Committee and a member (since 2006) of the campus Strategic Planning Committee. He served as Faculty Advisor to the Inter-Fraternity Council since 2003, to Blue Key since 2006, and as president of the Phi Kappa Phi chapter (1986-1989). He served the University of Missouri as a whole on the Patent, Copyright, and University-Sponsored Educational Committee (1982-2006), and the State of Missouri as Science Advisor to the Governors Kit Bond and John Ashcroft in the 1980s. In the local Rolla community he was a loyal and active member of the United Methodist Church and other organizations.

Nationally Don was a member of many scientific and professional societies, such a the American Intellectual Property Law Association, the National Society of Professional Engineers, Phi Kappa Phi, and the Technology Transport Society. Four societies elected him to Fellow status: the United Sates Association for Entrepreneurship and Small Business (1986), the International Council for Small Business (1987), the American Society of Engineering Management (2005), and the American Society for Engineering Education (ASEE, 2007). He has served ASEE in particular since 1982 as UMR Campus Representative (1982-1988), Midwest section officer (1988-1993 & 2002-2003), and Zone III Chair and member of the national Board Directors (1995-1997). He was scheduled to continue his service at the national level with a one year appointment in Washington, D.C., as a Franklin Fellow with the U.S. Department of State, beginning September 1, 2009.

One of Don's personal passions was bicycle riding, and he told a fellow member of the local Noon Kiwanis that he had ridden "like 25,000 or 30,000 miles." Characteristically, on Saturday, July 25, 2009 he was

participating with other bicyclists from Rolla and Missouri S & T in the Register's Annual Great Bicycle Ride Across Iowa. Near Burlington, Iowa, he had a serious accident, and was flown by helicopter to the University of Iowa Hospitals and Clinics in Iowa City, where he was pronounced dead the next afternoon, July 26, 2009. He will be severely missed.
